2. PROCEDURE TO CONFIRM ADMISSION

- 2.1. **Payment of Fee** – Total Fee amount is Rs. 2,50,000/- (Two Lakh Fifty Thousand Only). Due to the pandemic situation, the students may pay the amount in two equal instalments.
- 2.2. **The first installment of Rs.1,25,000/- should be paid on or before 22nd September, 2021 (before 5:00PM).**
- 2.3. Hostel facility is subject to availability. Those students who do not opt for/get hostel, the amount of Rs. 50,000/- will be adjusted in the second instalment.

4. SUBMISSION OF ADMISSION FORM AND DOCUMENTS

- 4.1. After the payment of fee, the candidates are required to download and fill in the Admission Form. The Admission Form can be downloaded from the University Website.

- 4.2. The filled in Admission Form is to be emailed to admissions@mpdnlu.ac.in on or before 23rd September, 2021 (before 10:00 AM).
- 4.3. The candidates are required to submit the scanned copies of the following documents as a single PDF file in the following order along with the Admission Form.
1. Degree Certificate of the Qualifying Examination.
 2. Marksheets for the Qualifying Examination (5 Years B.A./B.Com./BBA/B.Sc.LL.B. / 3 Years LL.B.).
 3. If the final marks are given in CGPA, conversion formula for the same.
 4. CLAT Score Card.
 5. Certificates/Documents to prove the category (if applicable).
 6. MP Domicile Certificate (if applicable).
 7. Proof of payment of Fee.

Note: If the candidate is not in a position to submit the Conversion Formula for percentage of marks of their respective Universities, they may give an undertaking to submit the same on or before 30th of September, 2021.

Note: If in case the candidate is not in a position to submit any of the above-mentioned documents, they can submit the fee and give an undertaking to submit their documents on or before 30th of September, 2021, failing which their candidature will be cancelled.

Note: In case if any of the documents submitted by the candidate is not authentic or the minimum criteria prescribed in the Notification is not met, his/her candidature will be cancelled.
