As per the Notification dated May 28, 2026 bearing S. No. REG/230/DNLU/2026-27, the University had invited applications for admission to the B.A.LL.B.(Hons.) Programme against the vacant seats. In response to the said notification, the University received 1057 applications. After announcing seven vacant admission lists, the University circulated an Expression of Interest to 139 applicants based on merit, via email and also attempted to contact them telephonically. Out of these, 43 applicants have expressed their willingness to take admission. Based on this, the list of provisionally selected students is being notified herewith.

The students whose names appear in the "Provisionally Selected Students" are required to pay the university fees **on or before September 10, 2026 5:00 PM** as per the details provided below. **Failure to pay the fees as per the direction will result in forfeiture of the offered seat.** You are required to report on September 10, 2026 at the university campus for document verification for confirming your admission.

INSTRUCTIONS:

- The candidates selected for provisional admission are required to pay an amount of Rs.3,15,000 /- (Rupees Three Lakh Fifteen Thousand Only) **on or before September 10, 2026 by 5:00 PM**. It is advised to not to wait for last moment to avoid any banking channel or ERP Server issues.

2. Instructions for Fee Payment:

1. Create an account at <https://academic.mpdnlu.ac.in/public/admission/login> by registering for the first time and then logging in. You can manage your fee payment and other information through this portal.
2. Go to LOGIN>MANAGE FEE and Pay your entire fees. You shall pay full fee as stated above irrespective of the payment made to the CLAT Consortium.
3. You can pay fees through Payment Gateway, this auto-verify the fees in realtime.
4. In case you opt for payment of fees through NEFT/IMPS/NEFT, you shall email the payment slip at admissions@mpdnlu.ac.in for verification.
5. You can download fee receipt and other document for the admission from the "Support TAB"
3. In case any selected student fails to pay the fees before the specified date and time given above, the university will cancel the offer of admission made to them. The Admission Committee will not entertain any request/communication in this regard.
4. Waitlisted candidates will be offered the seat as per the merit list based on their All-India CLAT Rank if there is vacancy arising on account of non-acceptance or revocation of admission offer letter or subsequent vacancy arising on account of withdrawal or cancellation of the admission.
5. The offer of admission made is provisional and it does not confer any right in favour of the student. The university shall not be responsible for any expenditure made by the candidate in this regard.
6. If at any stage the documents submitted or information furnished is found to incomplete or false, the university reserves the right recall the provisional selection and cancel the admission process of the concerned student.
