11TH PROVISIONAL LIST OF SELECTED STUDENTS FOR ADMISSION AGAINST THE VACANT SEATS

As per the Notification dated June 30, 2025 bearing S.No. REG/338/DNLU/2025-26, the University had invited applications for admission to the B.A.LL.B.(Hons.) Programme against the vacant seats. In response to the said notification, the University received 931 applications.

After announcing 10 Provisional Admission List, the University circulated an Expression of Interest to 150 applicants based on merit followed, via email and also attempted to contact them telephonically. Out of these, 89 applicants have expressed their willingness to take admission. Based on this, the merit list of provisionally selected willing students against the available seats is being notified herewith. In the event any candidate feels that they have expressed their interest for admission before the time prescribed in the email seeking expression of interest, and is above the closing rank of selected applicant (below), they may contact university by September 6, 2025.

The students whose names appear in the "Provisionally Selected Students" list are required to pay the University fees on or before Sep 08, 2025, by 5:00 PM as per the details provided below. Failure to pay the fees within the stipulated time will result in forfeiture of the offered seat. You are further required to report on or before Sep 08, 2025, at the University campus for document verification ([see Checklist of Documents](#)) to confirm your admission and continue studies.

INSTRUCTIONS:

1. The candidates selected for provisional admission are required to pay an amount of **Rs.3,13,000 /- (Rupees Three Lakh Thirteen Thousand Only) on or before Sep 08, 2025 by 5:00 PM**. It is advised to not to wait for last moment to avoid any banking channel or ERP Server issues. You are required to report on or before September 8, 2025 at the university campus for the document verification and continuing your studies.
2. **Instructions for Fee Payment:**
 - a. Create an account at <https://academic.mpdnlu.ac.in/public/admission/login> by registering for the first time and then logging in. You can manage your fee payment and other information through this portal.
 - b. Go to LOGIN>MANAGE FEE and Pay your entire fees. You shall pay full fee as stated above irrespective of the payment made to the CLAT Consortium.
 - c. You can pay fees through Payment Gateway, this auto-verify the fees in realtime.
 - d. In case you opt for payment of fees through NEFT/IMPS/NEFT, you shall email the payment slip at admissions@mpdnlu.ac.in for verification.
 - e. You can download fee receipt and other document for the admission from the "Support TAB"
3. Waitlisted candidates will be offered the seat as per the merit list based on their All-India Clat Rank if there is vacancy arising on account of non-acceptance or revocation of admission offer letter or subsequent vacancy arising on account of withdrawal or cancellation of the admission.
4. In case any selected student fails to pay the fees before the specified date and time given above, the university will cancel the offer of admission made to them. The Admission Committee will not entertain any request/communication in this regard.
5. The offer of admission made is provisional and it does not confer any right in favour of the student. The university shall not be responsible for any expenditure made by the candidate in this regard.
6. If at any stage the documents submitted or information furnished is found to incomplete or false, the university reserves the right recall the provisional selection and cancel the admission process of the concerned student.
