INSTRUCTIONS:

- The candidates selected for provisional admission are required to pay the balance amount of **Rs. 3,05,000/- (Rupees Three Lakh Five Thousand Only)**, being the university fee of Rs. 3,15,000/- (Rupees Three Lakh Fifteen Thousand Only) less the confirmation fee of Rs. 10,000/- (Rupees Ten Thousand Only) already paid, **on or before 23 September 2026 by 11:00 AM**. It is advised not to wait for the last moment to avoid any banking channel or ERP server issues.
- Instructions for Fee Payment:**
 - Create an account at <https://academic.mpdnlu.ac.in/public/admission/login> by registering for the first time and then logging in. You can manage your fee payment and other information through this portal.
 - Go to **LOGIN>MANAGE FEE** and pay the balance fee as stated above, irrespective of the payment made to the CLAT Consortium.
 - You can pay fees through Payment Gateway, which auto-verifies the fees in real time.
 - In case you opt for payment of fees through NEFT/IMPS/RTGS, you shall email the payment slip at admissions@mpdnlu.ac.in for verification.
 - You can download fee receipt and other document for the admission from the “Support TAB”.
- In case any selected student fails to report or to pay the balance fees before the specified date and time given above, the university will cancel the offer of admission made to them and the confirmation fee of Rs. 10,000/- shall stand forfeited. The Admission Committee will not entertain any request/communication in this regard.

4. Waitlisted candidates will be offered the seat as per the merit list based on their All-India CLAT Rank if there is vacancy arising on account of non-acceptance or revocation of admission offer letter or subsequent vacancy arising on account of withdrawal or cancellation of the admission.
5. The confirmation fee paid by a candidate who is not allotted a seat in this round will be refunded in full to the account from which it was received within ten (10) working days of the release of this list, without any deduction, if they are not offered seat in order of their merit for any subsequent vacancy.
6. The offer of admission made is provisional and it does not confer any right in favour of the student. The university shall not be responsible for any expenditure made by the candidate in this regard.
7. If at any stage the documents submitted or information furnished is found to be incomplete or false, the university reserves the right to recall the provisional selection and cancel the admission process of the concerned student.
