Hon'ble Shri Justice Sanjeev Sachdeva was born on 26th December 1964 in Delhi. He completed his schooling in commerce from Delhi Public School, Mathura Road, in 1982 and graduated with a B.Com (Hons.) from Shri Ram College of Commerce, University of Delhi, in 1985. He earned his LL.B. from Campus Law Centre, University of Delhi, in 1988 and was enrolled as an Advocate with the Bar Council of Delhi on 1st August 1988.

Justice Sachdeva practiced before the Supreme Court of India, Delhi High Court, and District Courts of Delhi. In 1995, he qualified as an Advocate-on-Record of the Supreme Court of India, securing second position in the examination. In 1992, he was awarded the British Council Scholarship to attend the Commonwealth Young Lawyers Course at the University of London, during which he also trained with solicitors and barristers in England.

He served as Standing Counsel for the Bar Council of India for over twenty years and was a Senior Panel Counsel for the Union of India for more than a decade. He has also played a significant role in advocacy training, having been a lead trainer under the Indo-British Advocacy Skills Project and conducting programmes for advocates across several High Courts in India.

Designated as a Senior Advocate by the Delhi High Court in 2011, he was elevated as an Additional Judge of the Delhi High Court in April 2013 and became a Permanent Judge in March 2015. He was transferred to the Madhya Pradesh High Court in May 2024 and appointed as the Chief Justice with effect from 17th July 2025 under Article 223 of the Constitution of India.



Dharmashastra National Law University, Jabalpur (hereinafter referred to as "DNLU") was established under the Madhya Pradesh Dharmashastra National Law University Act, 2018 (Act No. 24 of 2018). The University was formally inaugurated on 30 June 2018 by the Hon'ble Chief Justice of India, Shri Justice Dipak Misra, in the august presence of Shri Ravi Shankar Prasad, Hon'ble Union Minister of Law and Justice; Shri Shivraj Singh Chauhan, Hon'ble Chief Minister of Madhya Pradesh; Hon'ble Shri Justice Hemant Gupta, then Chief Justice of the High Court of Madhya Pradesh; along with other distinguished members of the legal fraternity from across the country.

The term Dharmashastra does not signify or represent any particular religion, caste, or creed. Rather, it is employed as a philosophical signifier denoting the essence of Dharma. At its core, Dharma embodies the principles of upholding, sustaining, and supporting society, promoting social order, harmony, and justice, and ensuring equality without discrimination. It reflects a commitment to righteousness and justice under all circumstances.

Programmes

Under Graduate Programme: B.A.LL.B. (Hons.)

The University offers a B.A.LL.B. (Hons.) with Political Science as a major subject and various law electives in the areas of Business Law, Constitutional Law, Criminal Law, International Law, Intellectual Property and law papers of contemporary significance. Admissions in the B.A.LL.B. (Hons) Programme are through the Common Law Admission Test conducted under the aegis of the CLAT Consortium.

Post Graduate Programme: LL.M. (One Year)

The university offers an LL.M. (1-year) postgraduate degree programme specialising in various areas of Business Law, Constitutional Law, Criminal Law, International Law, Intellectual Property Laws and law papers of contemporary significance. Admissions to the LL.M. (1-year) Programme are through the Common Law Admission Test conducted under the aegis of the CLAT Consortium.

- 1 50% Seats are horizontally reserved for candidates having domicile certificate of State of Madhya Pradesh in the respective categories including the General Category.
- 2 Reserved for candidates having the domicile certificate of State of Jammu and Kashmir.
- 3 Reserved for candidates from the Economically Backward Section. 06 seats under EWS category are reserved for candidates having the domicile certificate of State of Madhya Pradesh.

Note: Supernumerary seats are over and above the regular seats.

Horizontal Reservation

- a. 30% seats are horizontally reserved for women candidates.
- b. 5% seats are horizontally reserved for specially abled persons (Person with Disability)
- c. 5% seats are horizontally reserved for the candidates of M.P. domicile under the category son/grandson/daughter/granddaughter of Freedom Fighter, and wards of War Martyr of Defence Personnel and permanently Disabled Personnel of the Indian forces/dependent children of the Ex-Servicemen of CRPF/Indian Army.

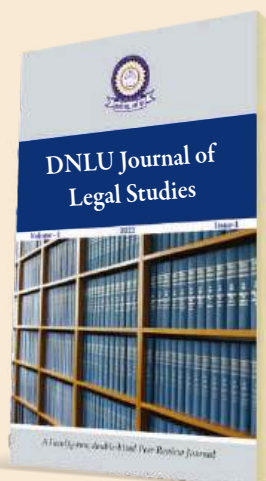


DNLU-Student Law Journal
