## NOTIFICATION FOR THE ADMISSIONS IN B.A.LL.B.(Hons.) AGAINST THE VACANT SEATS A.Y. 2026 - 27

Applications are invited from the candidates who have appeared in CLAT-2026 (held in December 2025) and are interested in taking admission in the B.A. LL.B. (Hons.) at DNLU, Jabalpur against the vacant seats or seats getting vacant subsequently. The interested candidates must apply ONLINE and pay application fee as specified. Online application form shall be submitted by June 4, 2026 latest by 11:59 pm.

The Application fee for seeking admission through the vacant list shall be as follows:

1. Rs.1000/- for Unreserved/J&K Resident
2. Rs. 750/- for SC/ST/OBC (non-creamy layer)/EWS

The application fee is non-refundable.

Note:

- Only the candidates who have qualified for the CLAT 2025 are eligible to apply.
- The merit list will be announced on the website of the university on June 05, 2026.
- If the University does not receive applications for the Reserved category, then as per the University's conversion policy, the vacant seats of the reserved category shall be opened to the Unreserved Category.
- In case of any future vacancy on account of withdrawal or cancellation, the vacant seats will be filled from the candidates enlisted in the merit list (in order of CLAT rank merit) prepared for the filling of vacant seats.
- Candidates will be considered for admission against the reserved category only if they have applied for the same in their CLAT admission form.
- Admission will be offered against the vacant seat subject to the fulfilment of the eligibility and completion of the admission formalities as per the given schedule.
- Candidates whose names appear in the University's provisional selection list shall be required to pay the First Year Fee for the Academic Year 2026-27, amounting to Rs. 3,15,000/- (Rupees Three Lakh Fifteen Thousand Only), on or before the date notified by the University. Applicants who fail to make the payment within the stipulated time shall forfeit their allotted seat.
