ABOUT DNLU



Dharmashastra National Law University, Jabalpur (hereinafter to be referred to as DNLU, Jabalpur) was established by the Madhya Pradesh Dharmashastra National Law University Act 2018 (24 of 2018). The Hon'ble Chief Justice of Madhya Pradesh High Court is the Chancellor of the DNLU, Jabalpur. The University is governed by the General Council, Executive Council, Academic Council and Finance Committee. The General Council is chaired by the Hon'ble Chief Justice, The Chancellor of DNLU, Jabalpur. The other Governing Bodies are Chaired by the Vice Chancellor. The Governing bodies have representatives from the Judiciary, the Government of Madhya Pradesh, legal professionals and renowned academicians.

National Law Universities Students' Association (NLUSA)

With the vision of building a vibrant and inclusive community for the benefit of all students, the National Law Universities Students' Association (NLUSA), spearheaded by Dharmashastra National Law University, Jabalpur, marks a pivotal step in fostering greater unity and collaboration among the student bodies of National Law Universities (NLUs) across India. The creation of NLUSA as a unified forum to address student concerns, enhance legal education, and advocate for the collective welfare of NLU students came to life through the tireless efforts of the Student Bar Association of DNLU, led by its President of the SBA. Officially established on 3rd May 2024, NLUSA aims to streamline the goals and functions of student representative bodies while preserving their autonomy.

STATEMENT OF INTENT

In light of the meeting between representatives of various existing student representative bodies of National Law Universities across India held on 21 April 2024 and 24 April 2024, wherein the Student Bar Association of Dharmashastra National Law University, Jabalpur, proposed to establish a unified forum for the collective representation of student concerns and interests. The existing student representative bodies of National Law Universities hereby declare their intent to establish the "National Law Universities Students' Association (NLUSA)."

Recruiters intending to participate in the Placement Drive can communicate their willingness to the Recruitment Coordination Committee (RCC) by email at rcc@mpdnlu.ac.in or telephonically on any of the contact numbers provided in this brochure. The RCC has framed the below stated rules, in chronological order, to facilitate smooth and optimal process while allowing the Recruiters necessary flexibility.

- **Pre-Placement Talks:** To apprise interested students of the organization and its practice areas, we encourage the Recruiter to conduct Pre-Placement Talks (PPT) with the students. These PPTs are aimed at highlighting the profile of the organization, job description, career prospects, compensation packages, et al., and can be conducted by the Recruiter, either via video conferencing or on campus, any time before Pre-Interview Screening Process.
- **Pre-Interview Screening Process:** The Recruiters may conduct Pre-Interview Screening Process at any time before the final interview and are free to determine their own policy to shortlist students. At the behest of the Recruiters, RCC may conduct Pre-Interview Screening Process. In absence of any such preference, Curriculum Vitae of all the interested students shall be forwarded to the Recruiter.
- **Final Interview:** Post Pre-Interview Screening, the Recruiter shall communicate a Final Interview List along with their preferred dates of interview. If the Recruiter deems appropriate, a list of waitlisted candidates may also be communicated who will be allowed to sit for Final Interview if any shortlisted candidate is unavailable for the interview. In cases where no Pre-Interview Screening Process is undertaken, all the interested students shall become eligible for the Final Interview.
- **Finalization and Disclosure of Offer:** The list of selected candidates and the final offer shall be communicated solely to RCC by the Recruiter. We urge the Recruiter to simultaneously disclose a waiting list. The RCC will revert to the Recruiter within 48 hours of receiving the offer letter.

The recruiters shall be required to send across information to the interested students only through a formal channel, i.e., RCC. At no point of time shall there be any communication between the Recruiter and the Candidate in relation to the offer. It may be noted that the rules are guiding principles and the Recruiters are welcome to follow their own recruitment process broadly within the framework of above-stated rules. The Placement Process is commencing with the start of September 2025 and will run throughout the Academic Year 2025-26. The Recruiters are free to undertake the entire process either on campus or in online mode based on their preference.
