#### TERMS AND INSTRUCTIONS TO BIDDERS

- 1. A pre-bid meeting is scheduled on 01.07.2025 at 11:00 Hrs in the Conference Hall of the DNLU, Jabalpur and interested bidders at their own cost can attend to inspect, examine the site and seek any clarification on the scope of work.
- 2. The tenderer shall themselves obtain all necessary information as to risks, contingencies and other circumstances which may influence or affect their tender.
- Submission of tender by a tenderer implies that he has read this notice and all other
  contract documents and has made himself aware of the scope and specifications
  of the work to be done and local conditions and other factors having a bearing on
  the execution of the work.

#### **ELIGIBILITY CRITERIA**

- 4. Only those bidders who meet the following eligibility conditions shall be considered:
  - (a) The bidder must be a proprietor, partnership firm, or company holding a valid GST registration certificate. The registered business address of the bidder as per the GST certificate must be located in Jabalpur, Madhya Pradesh.
  - (b) The bidder must have an average annual turnover of at least ₹15 lakhs during the last three financial years: FY 2021–22, 2022–23, and 2023–24, certified by a Chartered Accountant with a valid UDIN number.
  - (c) The bidder must possess a valid PAN card issued by the Income Tax Department.
  - (d) The bidder must submit self-attested copies of GST Returns for the financial years: 2021–22, 2022–23, and 2023–24.
  - (e) The bidder must submit self-attested copies of Income Tax Returns for the financial years: 2021–22, 2022–23, and 2023–24.
  - (f) The bidder must possess a valid trade license issued by the competent authority to operate in Jabalpur (M.P.), which must be at least 3 years old as on March 31, 2025.

#### **SUBMISSION REQUIREMENTS**

- 5. The bidder should submit the following documents along with their bid:
  - (a) Copies of Income Tax Returns, PAN, GST registration, and other relevant registrations.
  - **(b)** A signed and stamped copy of the entire tender document on each page, indicating acceptance of all terms and conditions.
  - (c) Required qualifying information including any technical specifications, experience details, or certifications.
  - (d) Bidders must submit documentary proof in support of each eligibility criterion as specified in ANNEXURE I (Technical Qualification Compliance)
  - (e) A list of all partners/directors of the firm/company.





#### SUPPLY TERMS AND CONDITIONS

- 6. The List of housekeeping items and cleaning machines as required under the housekeeping supplies are listed in **ANNEXURE I**
- 7. All housekeeping items supplied must be of reputed brand or equivalent, as approved by DNLU in terms of quality and quantity as per the tender specifications.
- 8. Cleaning Machines shall be in workable condition and the operator shall be provided by the supplier only.
- 9. The Vice-Chancellor, DNLU, reserves full discretion to accept or reject any tender, including the lowest bid, without assigning reasons. Canvassing in any form will disqualify the bidder.
- 10. All items under each quoted category must be included in the financial bid. Partial quotes shall be treated as non-responsive, subject to any relaxation by the university.
- 11. The rates for each item must be clearly handwritten. Overwriting or corrections without proper attestation will render the quotation invalid.
- 12. Rates quoted at time of tender shall remain same for a period of one year, inflating of rates after allotment of tenders shall not be entertained.
- 13. Unit rates should be quoted in Indian Rupees for each item against each brand/make. Any applicable GST/taxes must be clearly mentioned; otherwise, prices will be deemed inclusive of all taxes.
- 14. DNLU shall be under no obligation to accept the lowest or any tender received.
- 15. Tenders not conforming to the specified product requirements and brands will be summarily rejected.
- 16. A Rate Contract will be executed with the selected vendor. Purchases will be made on an as and when required basis during the contract period, and the vendor must accept part supply orders.
- 17. Delivery of housekeeping items and cleaning machines must be made within the days as specified in each supply order, depending upon the need of the item. Usually, 7 days' time shall be given for the supply of the housekeeping items and cleaning machines. Delay will result in penalties and possible cancellation of the order, along with forfeiture of the security deposit.
- 18. In case of failure to deliver as per supply order within the stipulated time, DNLU reserves the right to procure from the open market. The excess cost incurred shall be recovered from the vendor's security deposit or pending bills.
- 19. Vendors are encouraged to inspect the required items/specifications as per Annexure I before submitting bids.
- 20. The Vice-Chancellor, DNLU, reserves the right to cancel or reject any or all tenders without providing any reason
- 21. Vendors must ensure they have the logistical capability to deliver housekeeping





items and cleaning equipments to the DNLU Jabalpur campus premises at their own cost.

22. All purchase orders will be issued via email from reg@mpdnlu.ac.in to the vendor's registered email address.

#### PREPARATION AND SUBMISSION OF TENDER DOCUMENT

- 23. Tenders must be submitted strictly under a two-bid system. Bids not conforming to this structure shall be summarily rejected.
  - Bid-1: Technical Bid ANNEXURE II
  - Bid-2: Financial Bid ANNEXURE III

Note: Late submissions shall not be entertained under any circumstances.

#### 24. BID-1: TECHNICAL BID

- (a) The Technical Bid must be accompanied by the Earnest Money Deposit (EMD) and Tender Fee, each in the form of separate Demand Drafts drawn from any scheduled bank, in favour of "Registrar, Dharmashastra National Law University", payable at Jabalpur.
- (b) Micro and small enterprises and startups of Madhya Pradesh will be exempted from payment of earnest money deposit.
- (c) Technical and Financial Bids must be placed in separate sealed envelopes and clearly marked accordingly.
- (d) Bidders must submit documentary evidence supporting each eligibility criterion listed in **ANNEXURE II**.
- (e) Bids without the correct EMD and/or Tender Fee shall be summarily rejected.
- (f) A signed and stamped copy of the complete tender document (each page) must be submitted, indicating full acceptance of the terms and conditions.
- (g) The tender must be signed by an authorized signatory, with the signatory's name, designation, and official seal clearly indicated. Bids signed by unauthorized personnel will be rejected.

#### 25. BID-2: FINANCIAL BID

- (a) The Financial Bid must:
  - (i) Be submitted strictly as per the format in **ANNEXURE III**, with clear mention of applicable commercial terms and conditions.
  - (ii) Be placed in a separate sealed envelope, clearly superscribed: "Financial Bid Supply of Housekeeping Items and Cleaning Equipments at DNLU Jabalpur."
  - (iii) Include pricing that covers all transportation, freight, and other





- associated costs for the full contract duration.
- (iv) Conditional bids and those not conforming to the prescribed format shall be considered non-responsive and will be rejected.

#### **EVALUATION CRITERIA**

#### 26. Technical Evaluation

- (i) The Technical Evaluation Committee constituted by the University will assess the Technical Bids based on the eligibility criteria detailed in ANNEXURE II.
- (ii) Only technically qualified bidders will be invited for opening of the Financial Bids.
- (iii) The Committee's decision on technical qualification shall be final and binding.

#### 27. Financial Evaluation

- (i) Only Financial Bids of technically qualified bidders will be opened.
- (ii) The bidder quoting the lowest price (L-1) shall be identified as per the evaluation norms.
- (iii) In case more than one bidder qualifies as L-1, the one with the highest average annual turnover and longest valid trade license period shall be declared successful.

#### **CONTRACT TERMS**

#### 28. Implementation:

- (a) Sub-contracting is strictly prohibited and shall be treated as a material breach of contract.
- (b) Bidders must provide contact details including office landline, mobile number, and email for effective communication.
- (c) The bidder shall be liable for any injury, damage, or death caused to their personnel while executing the contract. DNLU shall not be held responsible in any such case.
- (d) The successful bidder must enter into an agreement with DNLU, Jabalpur on a non-judicial stamp paper of Rs. 500/-.

#### 29. The agreement may be terminated:

- (a) Automatically on expiry.
- (b) By either party with one month's notice.
- (c) By DNLU with immediate effect in case of breach, insolvency, or unauthorized sub-letting.
- 30. Services must continue during the notice period for smooth transition.



- 31. The successful bidder shall indemnify DNLU against all claims, damages, losses, or legal proceedings arising due to substandard supply or operational negligence.
- 32. The successful bidder must furnish a Performance Security Deposit equivalent to 5% of the total contract value. It shall be valid for the contract period plus 60 days.
- 33. The contract will remain in force for a period of 12 months from the date of award and may be extended upon mutual agreement.
- 34. In the event of natural calamities, strikes, government restrictions, or other force majeure events, both parties shall be relieved of their obligations temporarily. The affected party must inform the other party within 7 days of such occurrence.

#### **PAYMENT TERMS**

- 35. 100% payment will be released within 30 days of successful delivery and acceptance of the goods by DNLU.
- 36. No advance payments shall be made under any circumstances.
- 37. If GST or other taxes are not explicitly stated in the financial bid, it shall be assumed that the prices quoted are inclusive of all applicable taxes and duties.
- 38. DNLU is not bound to procure housekeeping items and cleaning equipment exclusively from the selected vendor during the contract period.
- 39. The vendor must ensure that the quality of items matches the specifications and approved brands. Any deviation will lead to rejection of goods.
- 40. All materials must be of high quality and adhere to government-approved standards. Substandard supplies will be summarily rejected.
- 41. The successful vendor shall deposit a Security Deposit of Rs. 50,000/-, which will be refunded after satisfactory completion of the contract without interest.

#### DISPUTE RESOLUTION AND JURISDICTION

- 42. In the event of any dispute or disagreement arising under or in relation to this tender or subsequent agreement, the parties shall attempt to resolve the matter amicably.
- 43. Failing such resolution, the matter shall be referred to arbitration under the Arbitration and Conciliation Act, 1996. The arbitrator shall be appointed by the Vice-Chancellor, DNLU Jabalpur, and the decision shall be final and binding.
- 44. All legal proceedings shall be subject to the exclusive jurisdiction of the courts at Jabalpur, Madhya Pradesh.

#### INTERPRETATION CLAUSE

45. In case of ambiguity in interpretation of any clause in the tender or contract, the interpretation provided by DNLU, Jabalpur shall be final and binding on all parties.
