2. **Instructions for Fee Payment:**
 - Register yourself at erp.mpdnlu.ac.in by clicking "Student Register."
 - After Registration, login to erp.mpdnlu.ac.in.
 - Go to **Profile > Edit** and update your profile by filling in details for **General Information, Academic Qualification, Documents and Profile Images**.
 - Once your Profile is complete, the university will update your fee. Kindly be patient as the university verifies your details before updating the fee.
 - Go to **Fees >** and if the Fee demand is shown to you, click "**Pay Now**".
3. In case any selected student fails to pay the fees before the specified date and time given above, the university will cancel the offer of admission made.
4. The Admission Committee will not entertain any request/communication in this regard.
5. Waitlisted candidates will be offered the seat as per the merit list based on their All-India Clat Rank if there is vacancy arising on account of non-acceptance or revocation of admission offer letter or subsequent vacancy arising on account of withdrawal or cancellation of the admission.
6. The offer of admission made is provisional and it does not confer any right in favour of the student. The university shall not be responsible for any expenditure made by the candidate in this regard.
7. If at any stage the documents submitted or information furnished is found to be incomplete or false, the university reserves the right recall the provisional selection and cancel the admission process of the concerned student.
