## General Policies

Our journal adheres to the highest standards of academic integrity. We accept papers based on their originality, significance, and contribution to the field. All submitted papers undergo a rigorous peer-review process to ensure the quality and relevance of the research. We are committed to transparency, fairness, and equality in the submission, evaluation, and publication processes.

The Submission of research work or interview must have the following attached :

- Cover letter indicating name of the author(s) and interviewer along with interviewee, Institutional Affiliation, details of contact and theme of the interview/ topic of the paper.
- We allow a maximum of three authors along with the first author. In case of multiple authorship, cover letter must contain details of each author as mentioned in clause (I).
- It shall be the responsibility of the author to intimate the Editorial Board regarding any change in designation during the period in which the paper is being processed. No changes will be entertained after publication.

## Categories of Submissions

### 1. Interview Corner

This section features insightful and substantive conversations with eminent personalities from the fields of law, policy, governance, and the social sciences. Interviews should address contemporary themes, offer critical perspectives, and contribute meaningfully to scholarly and policy discourse.

**Eligibility:** Submissions may be made by professionals, scholars, or practitioners conducting or curating interviews with distinguished and reputed figures in the relevant domains.

### 2. Academician Corner

This section provides a dedicated platform for academics, researchers, and professionals to contribute original, analytical, and research-driven works on



contemporary legal, policy, and social issues. Submissions are expected to demonstrate academic rigour, critical engagement, and meaningful contribution to emerging scholarly debates.

## **Accepted Formats**

- **Long Articles**

In-depth, original research offering novel arguments or perspectives on relevant themes. These articles should demonstrate comprehensive research, theoretical clarity, and engagement with authoritative sources to advance scholarly discourse.

Word Limit: 3,500–10,000 words (exclusive of footnotes).

- **Short Articles**

Scholarly discussions addressing contemporary issues, emerging themes, or innovative perspectives. These submissions must be concise yet analytically rich, offering sharp insights into current developments without compromising academic depth.

Word Limit: 1,200–3,500 words (exclusive of footnotes).

- **Legislative & Case Comments**

Analytical commentary on recent judicial decisions, legislative developments, or policy reforms. Submissions should identify key legal or policy implications, provide doctrinal or critical analysis, and contextualise the development within broader jurisprudential debates.

Word Limit: up to 2,000 words (exclusive of footnotes).

## **Book Reviews**

- Critical evaluation of recently published works in law, social sciences, or allied disciplines. Reviews must analyse the methodology, arguments, and contribution of the work, offering constructive critique and situating the book within existing scholarship.

Word Limit: 1,000–1,500 words (exclusive of footnotes).

- **Eligibility**

Submissions are invited from academicians, practitioners, and postgraduate researchers.



### 3. Student Corner

This segment provides an academic platform for undergraduate and postgraduate students to present research-driven perspectives on contemporary issues relevant to law, policy, and allied social sciences. Submissions should be well-researched, analytically sound, and reflective of independent scholarly thought dealing with contemporary legal, policy, and social issues. Submissions are expected to demonstrate academic rigour, critical engagement, and meaningful contribution to emerging scholarly debates.

#### Accepted Formats

- **Long Articles**

In-depth, original research providing novel arguments or theoretical advancements on pertinent issues. Submissions should demonstrate strong research foundations, critical analysis, and engagement with authoritative academic sources.

Word Limit: 3,500–10,000 words (exclusive of footnotes)

- **Short Articles**

In-depth, original research providing novel arguments or theoretical advancements on pertinent issues. Submissions should demonstrate strong research foundations, critical analysis, and engagement with authoritative academic sources.

Word Limit: 3,500–10,000 words (exclusive of footnotes)

- **Legislative & Case Comments**

Critical commentary on recent judicial decisions, legislative developments, or policy initiatives. Submissions should identify core legal questions, provide refined doctrinal or policy analysis, and situate the issue within broader constitutional or jurisprudential contexts.

Word Limit: up to 2,000 words (exclusive of footnotes)

- **Book Reviews**

Critical analysis of recently published works in law, social sciences, or allied fields. Reviews should move beyond descriptive summaries to evaluate the book's methodology, scholarly relevance, and contribution to academic discourse.



Word Limit: 1,000–1,500 words (exclusive of footnotes).

*Note: Reviews must include complete bibliographic details, including author's name, title, publisher, year of publication, and ISBN.*

- **Eligibility**

Undergraduate and postgraduate students of law and social sciences.

## **Formatting & Citation Standards**

- **Language:**

Submissions must be written in English. Authors are required to maintain consistency in language throughout the manuscript.

- **Abstract:**

Each submission must be accompanied by an abstract of 250–300 words, briefly outlining the research objectives, methodology (where applicable), and key findings or arguments.

- **Formatting Requirements:**

- ◆ Font: Times New Roman

- ◆ Font Size: 12 pt

- ◆ Line Spacing: 1.5

- ◆ Margins: 1 inch on all sides

- ◆ Page Numbers: All pages must be numbered consecutively.

- **Citation Style:**

Footnotes must conform to APA (7th Edition). Authors are expected to ensure accuracy, completeness, and uniformity in citations and references.



- **File Format:**

All submissions must be uploaded in .doc or .docx format. PDF submissions will not be accepted.

#### **4. General Guidelines**

- All manuscripts must be original, unpublished, and not under consideration elsewhere. Submissions found to violate originality or exclusivity requirements may be rejected at any stage of the review or publication process. AI-generated or AI-assisted manuscripts are strongly discouraged. The Journal expects all submitted work to represent the author's original academic effort.
- The Editorial Board reserves the right to reject any submission that does not meet the Journal's academic, editorial, or ethical standards. The Board may also request revisions to ensure quality, clarity, and adherence to publication standards.
- The Journal maintains high ethical standards and follows a strict anti-plagiarism policy. All submissions will be screened for similarity. Manuscripts containing plagiarised content exceeding 10% (excluding permissible academic references and quotations) will be summarily rejected.
- Themes announced in the Call for Papers are illustrative and not exhaustive. Authors are encouraged to explore relevant and emerging issues within the broader scope of the Journal's interdisciplinary mandate.
- The Journal welcomes submissions from scholars and practitioners across jurisdictions to foster diverse and global academic dialogue.

#### **5. Submission Procedure**

- All manuscripts must be submitted electronically through the Journal's official website submission portal. Submissions sent via email or through any means other than the designated portal will not be considered unless otherwise specified.
- Authors will be notified of the review outcome in accordance with the Journal's peer-review timeline. The Journal follows a structured review and communication process, and authors are advised to refrain from simultaneous queries unless the review period has lapsed.
- All submissions must adhere to the [UGC guidelines \(level 0\)](#). Use of AI generated content is strictly prohibited.
