Be it a matter of contract, property, family dispute or any dispute of civil nature, in the interest of clients as well as the administration of civil justice the young counsels should have the exposure of skilful insights of civil litigation.

The objective of the three days programme is to provide the platform to young advocates of Madhya Pradesh to have discourse from the stage of filing of Pleadings, rejoinder, admission/denial of documents, framing of issues by Court, leading evidence, cross-examination by parties, appreciation of evidences by court, final arguments and then finally the judgment/decree with the distinguished luminaries of Civil Litigation which to include Sitting High Court Judges, Retd, Judges, Advocates and Academicians.

Eligibility

- Candidate should have been enrolled as an advocate and should have been engaged in actual practice in Trial/District or appellate courts of Madhya Pradesh.
- 2 Candidate must not be in other full-time or part-time job/profession other than practice at Bar.
- 3 Candidate should not be above the age of 30 years;
- 4 Candidate should also be ready and willing to make available his/her services for University's Legal Aid Cell and District Legal Aid Authority.
- 5 All candidates must undertake to be formally dressed in the Advocate's attire during the training programme.

Registration/Nomination Process

- 1 The Last date for Registration is 10th February, 2023.

- Nominations by Bar Associations of the District, High Court and State Bar Councils can be made in consultation with the Organizing Committee.
- 4 Participants from outside Jabalpur shall undertake their own cost of travel and accommodation.
