


Hon'ble Shri Justice Ravi Malimath

Hon'ble the Chief Justice, High Court of Madhya Pradesh & Chancellor, Dharmashastra National Law University, Jabalpur

Born on 25.05.1962 in one of the most respected families of Karnataka. Justice Ravi Malimath graduated in Commerce from M.E.S. College, Bangalore and completed his Law Degree from Sri Jagadguru Renukacharya College of Law. Thereafter, he joined the chambers of Sri Shivraj Patil, who was, later on, elevated as a Judge of the High Court of Karnataka and, thereafter, as a Judge of the Supreme Court of India. Justice Malimath had practiced in all fields of law such as Constitutional, Civil, Criminal, Labour and Service. He was appointed as an Additional Judge of the High Court of Karnataka on 18.02.2008 and as a Permanent Judge on 17.02.2010. Many landmark judgments were delivered by him. As a Judge of the High Court of Karnataka from 18.02.2008 to 02.03.2020, he has delivered final judgments in 44,886 cases. The statistics indicate that this is one of the highest number of disposals in the State. As a Judge of the High Court of Karnataka, he worked very effectively as the Administrative Judge of many districts. He chaired various Administrative Committees. He was the President of the Bangalore Mediation Centre from 01.05.2017 to 26.01.2018. He was the President of the Karnataka Judicial Academy from 27.11.2018 to 12.01.2020. He was the Executive Chairman of the Karnataka State Legal Services Authority from 06.10.2019 to 04.03.2020. He was transferred as a Judge of the High Court of Uttarakhand and was administered oath on 05.03.2020. He was appointed as the Executive Chairman of the Uttarakhand State Legal Services Authority w.e.f. 13.05.2020. He was appointed as the Acting Chief Justice of the High Court of Uttarakhand w.e.f. 28.07.2020. Various reforms for the betterment of the judiciary in Uttarakhand were undertaken. He was transferred and took oath as a Judge of the High Court of Himachal Pradesh on 07.01.2021. He was appointed as the Executive Chairman of the Himachal Pradesh State Legal Services Authority on 25.02.2021. He assumed charge of the office of Chief Justice (Acting) w.e.f. 01.07.2021. He was elevated and transferred as the Chief Justice of High Court of Madhya Pradesh and took oath of office on 14.10.2021.

Dharmashastra National Law University, Jabalpur (DNLU, hereafter) was established by the Madhya Pradesh Dharmashastra National Law University Act 2018 (24 of 2018). The University was unveiled by the Hon'ble Chief Justice of India, Shri Justice Dipak Misra, on 30th June, 2018 in the august presence of Shri Ravi Shankar Prasad (Hon'ble Union Minister of Law and Justice), Shri Shivraj Singh Chauhan (Chief Minister, Madhya Pradesh), Hon'ble Shri Justice Hemant Gupta (Chief Justice, High Court of Madhya Pradesh) and other dignitaries of legal fraternity across India.

The name Dharmashastra does not signify any particular religion, caste, and creed. It is used as a signifier to signify the essence of Dharma. The basic attribute of 'Dharma' is to uphold, bear, endure, and support the society without any kind of discrimination and also to maintain order and harmony among people and ensure that they are committed to defending the ideals of righteousness and justice in any circumstances.

DNLU is a fully residential campus and it started its first academic session (2018-19) at the Bharat Ratna Bhim Rao Ambedkar Institute of Telcom Training (BRBRAITT, hereafter), Ridge Road, Jabalpur. BRBRAITT is the apex training institute of Bharat Sanchar Nigam Limited and it holds the pride of being the oldest training centre in the field of Telecommunication in Asia. It has a clean, green, fully safe, and secured campus.

In the temporary set up DNLU has established a fully furnished academic block, classrooms,

seminar hall, auditorium, library, canteen, and made proper arrangement for indoor and outdoor sports facilities. The University has 4 separate hostel facilities for boys and girls. All hostels are situated in the vicinity of the University campus and within a walkable distance from Academic building.

Government has allotted 125 acres of land to the university in the lush green and pleasant surroundings, adjacent to the Jabalpur Airport to establish a state-of-the-art infrastructure, equipped with all modern amenities as a green and clean campus, technically equipped classroom, e-library, language lab, gymnasium, mess, etc.

Programmes

Under Graduate Programme: B.A.LL.B. (Hons.)

The University offers a B.A.LL.B. (Hons.) with Political Science as a major subject and a Law Honors with specialisation in the areas of Business Law, Constitutional Law and Criminal Law. Students can also gain a degree of General Honors if they desire to not follow any particular specialisation. Admissions in the B.A.LL.B. (Hons) Programme are through the Common Law Admission Test conducted under the aegis of the CLAT Consortium.

Post Graduate Programme: LL.M. (One Year)

The university offers an LL.M. (Hons.) 1-year postgraduate degree programme specialising in Business Laws or Criminal Laws. Admissions to the LL.B. (Hons) Programme are through the Common Law Admission Test conducted under the aegis of the CLAT Consortium.

- * Only those OBC candidates can claim reservation under this category whose parental income is less than the prescribed sum for creamy layer. Such candidates have to produce requisite certificate from competent authority to the effect that their parents at present do not come under creamy layer category.
- 1 50% Seats are horizontally reserved for candidates having domicile certificate of State of Madhya Pradesh in the respective categories including the General Category.
- 2 Reserved for candidates having the domicile certificate of State of Jammu and Kashmir.
- 3 Reserved for candidates from the Economically Backward Section. 06 seats under EWS category are reserved for candidates having the domicile certificate of State of Madhya Pradesh.

Note: Supernumerary seats are over and above the regular seats.

Horizontal Reservation

- (a) 30% seats are horizontally reserved for women candidates.
- (b) 5% seats are horizontally reserved for specially abled persons (Person with Disability)
- (c) 5% seats are horizontally reserved for the candidates of M.P. domicile under the category son/grandson/daughter/granddaughter of Freedom Fighter, and wards of War Martyr of Defence Personnel and permanently Disabled Personnel of the Indian forces/dependent children of the Ex-Servicemen of CRPF/Indian Army.

Seat Conversion

If the seats of reserved category (SC, ST, OBC) lie vacant due to non-availability of suitable candidates/students, then it shall be filled up from candidates/students from unreserved General Category.

Note:

- A total of 8 papers in each of the honours streams will be offered to the students. The proposed honours streams to be offered are 1. Business Law, 2. Criminal Law & 3. Constitutional Law. The Student can also opt papers across three streams to earn a general honours. 8 papers to be offered in the respective honours streams will be decided, when it is to be offered. Students will have the liberty to study 8 honours papers cutting across the 3 streams or only study 8 papers of one honours stream. The 6 Optional Papers to be offered to the students will also be decided, when it is to be offered. Further, in respect of the language paper, apart from English, the University may offer other language papers depending upon the availability of the faculty. The Moot Court & Internship Paper in the X Semester will together carry 100 Marks and 4 Credits. Out of 100 Marks, 70 Marks shall be for internship and 30 Marks shall be for Moot Court.
- Each student must study three papers of two subjects from Social Sciences out of History, Economics and Sociology as Minor Subjects in Social Sciences. Political Science is the only major subject to be offered in Social Sciences, in which each student must study six papers.
- The course matrix may be changed as per the discretion of the university authority.




