## Revised Fee Refund Policy for the Session 2023-24

1. A full refund of fees (i.e., entire fee, zero cancellation charges apart from the Bank processing charges) shall be made on account of all cancellations of admissions / shifting of students to other National Law University admitted through CLAT Consortium List for the academic session 2023-2024. (till 5<sup>th</sup> list of CLAT Consortium)
2. Fee deposited against the admission for B.A.L.L.B. (Hons.)/ L.L.M. course through first, second, third, fourth and fifth list issued by the CLAT Consortium (upgraded) subsequently, their fees shall be transferred to such other National Law Universities by the DNLU, Jabalpur. However, if the entrant chooses to withdraw his /her admission from DNLU after the release of the fifth list released by the CLAT Consortium, the fee, upon request made by the entrant will be refunded to his/her account from which the fee was paid (details of which are supplied to the admission email id by the entrant), after the deduction of bank processing charges or any such amount which may be prescribed by till 22nd July, 2023 CLAT to be deducted in case of 'float option' to the other National Law Universities.
3. The entrant admitted against the vacant seat notified by the Dharmashastra National Law University's Admissions Office and entrant admitted through CLAT Admissions Process, after completion of the CLAT admission process through CLAT Consortium Office, if withdraws from the admission, shall be eligible for refund of his / her fees i.e. the component of Admission fee + Tuition Fee + Refundable deposits in full as per the UGC Refund Policy dated 03rd July 2023 and for the component of Utilities being provided by the University, on pro-rata basis for the period 01st Aug' 2023 to 31st Oct' 2023 as defined below:-
4. Total Value of the Utilities Component – ((Total Value of the Utilities Component x No. of days of Student's stay in the University)/ 150 days)
5. As per DNLU norms a semester consist of 150 working days, hence the same is affected in the calculation above.
6. As per the attached fee structure of the University, for the current financial year the total value of Tuition fee and Refundable deposit comes to Rs.1,45, 000/- (Rupees One lakh Forty Five Thousand Only) and the total value of Utilities component is Rs.1, 38,100/- (Rupees One Lakh Thirty Eight Thousand Only).

7. The entrant admitted in the University (through CLAT Consortium or admitted against the vacant seat) if withdraws after 31st October, 2023, he/she shall not be eligible for refund of his/her fee except Refundable deposit.
